Long Term Comprehensive Planning Committee:

Strategic planning needs to start with the FODTP group to help guide P&R in what is needed. Kelly & Lyle researched several currently owned parks in Lincoln a pro's & con's sheet of potential off-leash parks in Lincoln, NE.

Kelly presented examples of information from the Great Plains Trails Network:

- **1.** Their mission statement and goals
- 2. Links that they use on their website.
- **3.** Examples of their board meeting minutes, newsletters and Draft Agenda's that the Great Plains Trails Network utilize.

Statistical information Lyle found regarding Lincoln, NE and dogs.

- 1. Per Animal control there is approximately 41,000+ licensed dogs.
- 2. Per city-data.com
 - a. Population is 265,000+ 17% growth since 2000
 - b. Historical Housing = 110,000+ with 1200 home sales in 3rd quarter of 2014

- c. City of Lincoln is 74.6 square miles
- d. Population Density 3356 people per square mile
- e. Mean Travel Time to work 17.2 miles
